



OUR EMISSIONS HAVE DECREASED BY 17.5% SINCE 2021




Values in metric tones CO₂E* *CO₂E - carbon dioxide equivalent




We are honored to have received the Gold Medal in the 2023 EcoVadis Sustainability Rating for our site in France.

Additionally, we have transitioned to green energy at several of our locations. The certificate below pertains to our headquarters in Germany.



New Health-Conscious & Environmentally-Friendly Products

In 2023, Castolin Eutectic launched a range of innovative products prioritizing the health and safety of operators.

We have reformulated the composition of our EnDOtec 611X welding wire to eliminate chromium, a metal extensively used in welding products. This reformulation eradicates the risk of exposure to hexavalent chromium fumes, which are potentially carcinogenic. Furthermore, we prepared to extend our EnDOtec SafeHard range, which is free from both chromium and nickel, as well as the launch of our SafeCoat coating powders, which replace nickel with iron. Nickel exposure is associated with numerous health issues, including allergies, cardiovascular diseases, lung and kidney conditions. It is also crucial to prevent nickel from contaminating the atmosphere and water cycle.

In terms of equipment, we have introduced the EuTronic Arc Spray EAS1-i, which is more energy-efficient due to the incorporation of inverter technology instead of traditional transformers.


