The Central Warehouse Europe (CWE) is the warehouse for the European market centres of the Castolin Eutectic group. It is owned by Castolin Eutectic GmbH.

CWE is responsible for the following:

- Planning and purchasing of all materials that are traded through the warehouse
- Shipping goods directly to the end customers of all the European Market Centres on their behalf
- Shipping goods to the Market Centres for their production and or service needs
- Entering the orders for all non-European Market Centres and ship from CWE to the Market centre
- Completing Export Control, Logistics and customs controls for all non-European Market Centres

Products that are handled include: metal powders, electrodes, flux cored wires, solid wires, fluxes, brazing pastes, welding consumables, equipment and spare parts.

The company shall ensure that the quality and environmental systems are maintained and comply with the requirements of the Quality and Environmental Standards, I.S. EN ISO 9001:2015 and I.S. EN ISO 14001:2015 respectively.
